



Application Form 2018 Motorsport Ireland Media Accreditation

Motorsport Ireland accreditation may be issued to members of the media who currently publish or broadcast to the general public via newspapers, motor sport periodicals, national or local radio and national TV. Website work will also be considered, based on an assessment of quality, content and traffic.

In order to qualify for consideration, the applicant must submit the following:

1. A completed Application Form and signed Indemnity.
2. A signed letter on an official letterhead from a publisher or broadcaster confirming that they regularly publish or broadcast the applicant's work.
3. One passport sized photograph.
4. **FOUR** examples of published, accredited motor sport work (cars) from the last 12 months **OR** a copy of the applicant's current NUJ, ASJI or PPAI membership card. Accredited work must fall under MI, ASN, FIA umbrella – i.e. anything that is not governed by MI, another ASN Affiliated to the FIA or the FIA is not eligible,
